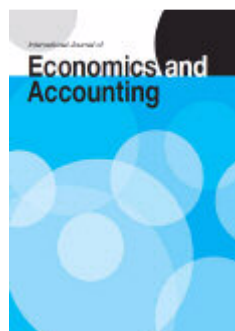
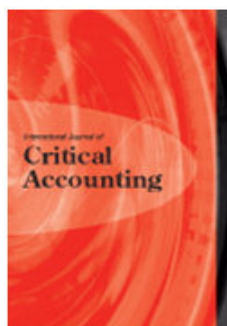

The *Third Accounting and the New Labor Process Symposium* (3rd ANLP) will take place at Babes-Bolyai University, Faculty of Economics and Business Administration, 58-60 Teodor Mihali Street, Cluj-Napoca, Romania on November 26, 2009.

The 3rd ANLP is one of four events scheduled at this meeting. The complete program includes:

- *Transylvanian Initiative for Accounting Research Development Workshop*

Papers or abstracts for the 3rd ANLP should be submitted as MS Word email attachment to tony.tinker@baruch.cuny.edu before October 25, 2009. Early Submissions are Welcome. Only submissions that are available for eventual review for the International Journal of Critical Accounting or the International Journal of Economics and Accounting should be submitted to the symposium. The review process will begin prior to the meeting.
