We invite submission of research papers in Economics for **ERMAS 2019: the sixth annual scientific conference of Romanian academic economists**, from both Romanian- and non-Romanian speaking economists. The conference will take place within **July 31 - August 02, 2019, at the Faculty of Economics and Business Administration (FSEGA), Babeș-Bolyai University (UBB), in Cluj-Napoca, Romania**. The submissions will be evaluated and selected by a Scientific Committee composed of Romanian economists with research output recognized internationally. Submission instructions

Please submit your paper as a single PDF—including on its first page the paper's title, authors' names and affiliations, an abstract of maximum 200 words, a maximum of 3 JEL codes, and a maximum of 5 keywords—as an attachment to your email sent to ermas2019cluj@gmail.com. The papers can be submitted starting from January 10, 2019. **The deadline for paper submissions is April 1, 2019, 23.59 hours GMT+2 (Bucharest's time)**. If you do not receive a confirmation of your submission in max two-three days, please re-contact us. **Each person can submit one single paper**, although s/he can be an author of other papers submitted to the conference (by co-authors). In the case of papers with multiple authors, please mention once more in your submission email who is the intended presenter. **All papers and presentations will be in English. Foreign economists may also submit papers**, although **the majority of the contributed presentations is intended to remain by Romanian economists** with affiliations from either outside or inside Romania: the final proportion of presentation slots allocated for foreign economists will be determined by the Scientific Committee—based on the overall distribution quality of papers received for evaluation.
