Participants who have expressed their wish to participate in the I International Distance Olympiad according to the International Evaluation Standards should send an application in the established form (*Appendix* 1) by November 30, 2020 to the e-mail: <u>ksu.bua@mail.ru</u>. Applications received later than November 30, 2020 are not considered. On the 1st round - each participant is tested online at the link: e.ksu.kz. (reference activity period - December 8, 2020 from 2 p.m. to 4 p.m., Nur-Sultan time (Kazakhstan). The second round of the Olympiad is open to participants who have successfully passed the 1st round. Case studies are sent to the e-mail address specified in the participant's application form. The participants send their case studies in electronic form to the e-mail address: <u>ksu.bua@mail.ru</u> December 9, 2020 (till 13:00 h., Nur-Sultan time (Kazakhstan).

1.1.The present Regulations of the I International Distance Olympiad according to the international standards of evaluation define the goals, objectives, procedure, conditions of the contest, participation and summarizing of the results.

1.2.Organizer of the Olympiad: Karaganda University of the name of academician E.A Buketov, Economics Department, Accounting and Audit Department.

1.3 Partner of the Olympiad: "Karaganda Chamber of Kazakhstan Valuers Association".

1.4. Management, preparation and holding of the Olympiad is carried out by the Department of Accounting and Audit of Karaganda University of the name of academician E.A Buketov.

1.5 The Olympiad languages: Kazakh, Russian, English.

1.6. Form of the Olympiad: remote.

1.7 The information about the preparation and holding of the Olympiad is placed on the website of Karaganda University of the name of academician E.A Buketov - www.ksu.kz and social networks at the following addresses:

## 2. OLYMPIAD PURPOSES AND OBJECTIVES

2.1. Purposes of the Olympiad:

- improvement of the quality of training of qualified specialists, development of creative abilities of students and masters, as well as increasing students' interest in educational activities and future profession;

- to promote professional growth of gifted students and involve them in continuing education at the master's level through the educational program "Evaluation".

2.2. Objectives of the Olympiad:

- stimulation of educational and cognitive and research activities of students and master's students in the field of evaluation;

- disclosure of professional and personal potential of students, their self-awareness, creation of conditions for self-realization and self-assertion;

- develop practical skills in business evaluation in accordance with international evaluation standards;

- support the most talented and gifted students and graduate students;

- to increase students' cognitive interest in international assessment standards;

- improve the quality of training of future qualified specialists in the field of international evaluation standards;

- development of personal skills in the participants of the Olympiad that increase the human capital of future qualified specialists;

- popularization of scientific and practical knowledge among students;

- strengthening ties between academic and student communities of leading universities in the field of economic sciences.

### **3. OLYMPIAD PARTICIPANTS**

3.1. The Olympiad is an intellectual competition for evaluation of undergraduate students (2-3-4 courses) and graduate students of higher educational institutions of the Republic of Kazakhstan and foreign countries.

3.2. Participation in the Olympiad is voluntary and free for participants.

3.3. Participation in the Olympiad is individual.

3.4. The Organizing committee has the right to demand the documentary confirmation of the corresponding status of the participant of the Olympiad (the certificate from the educational institution, confirming the status of the student with the indication of the course of study, the student's ticket, the credit book or etc.).

# 4. PROCEDURE FOR ORGANIZING AND CONDUCTING THE OLYMPIAD

4.1 The Organizing Committee (hereinafter referred to as the Organizing Committee) and the Jury shall be established for the Olympiad.

4.2 The Organizing Committee shall be formed from the faculty of economics faculty of the name of academician E.A. Buketov. The composition of the jury consists of the faculty members of the Faculty of Economics KarU of the name of academician E.A. Buketov, representatives of research organizations and the business community and approved by the Chairman of the Organizing Committee.

4.3. The Chairman of the Organizing Committee of the Olympiad is the Rector of KarU of the academician E.A. Buketov.

4.4 The Olympiad is managed by the Deputy Chairman of the Organizing Committee or the Executive Secretary. The composition of the Organizing Committee and the Jury shall be approved by order of the Rector.

4.5. The Organizing Committee shall perform the following functions:

- Approves the rules of the Olympiad;

- form the Jury, taking into account that the simultaneous membership in the Jury and the Organizing Committee is not allowed;

- ensures the direct holding of the Olympiad events;
- approves the list of winners and prizewinners of the Olympiad;
- awards the winners and prizewinners of the Olympiad;

- provides free access to the regulations and information about the Olympiad schedule, composition of participants, winners and prizewinners;

- develops tasks and a set of training and methodological materials for participants;

- defines criteria and methods for evaluation of the completed tasks;

- performs other functions aimed at achieving the goals of the Olympiad.

4.6. The jury of the Olympiad carries out the following functions:

checks the results of the individual tasks performed by the participants of the Olympiad;

- defines the winners and prize-winners of the Olympiad;

- makes proposals to the Organizing Committee to improve the organization of the Olympiad;

- performs other functions aimed at achieving the goals of the Olympiad.

4.7. The decisions of the jury of the Olympiad are executed by the protocol and transferred to the Organizing Committee for preparation of the order about the final results.

4.8. The decision of the Jury is final and not subject to appeal.

#### **5. OLYMPIAD REGULATIONS**

5.1 The content and complexity of the contest tasks of the Olympiad correspond to the educational program "Evaluation".

5.2 The Olympiad consists of two rounds: 1 - testing, 2 - case studies solution.

5.2.1 **The first round "Testing"** is held from December 8, 2020 from 14.00 to 16.00 on time Nur-Sultan (Republic of Kazakhstan). Everyone is tested online at the following link: **e.ksu.kz.** (International Evaluation Standards Olympiad).

5.2.2 **Second round "Case Tasks Solution"**. By the second round of the Olympiad the participants who have successfully passed the testing are admitted.

5.3 Case study solution is sent **on December 9, 2020** (by 13:00 h. time Nur-Sultan (Republic of Kazakhstan) in electronic form (scanned) to e-mail: <u>ksu.bua@mail.ru</u>. In the subject of the letter specify: "**Olympiad\_Name of the university**". The decision to provide in electronic form.

5.4 Tender documents are kept with the Organizer and not returned.

5.7 The participants of the Olympiad at each of the rounds get points which are further summarized.

#### 6. SUMMARIZING

6.1 The results of the awarding of the winners are summed up by the organizing committee of the Olympiad as advised by the jury.

6.2 The winners are the participants who have scored the highest average final points.

6.3 The winners of the Olympiad are awarded with the diplomas of the winner of I, II, III degrees, scientific leaders - with letters of thanks.

6.4 The Olympiad Organizing Committee has the right to approve additional nominations for awarding the participants of the Olympiad. Availability and number of places are not regulated by these Regulations.

6.5 Diplomas and letters of appreciation will be sent to scientific leaders to their e-mail addresses by **December 25, 2020**.

6.6 All disputable questions or questions that are out of the scope of the present Regulations or Rules shall be solved by the Olympiad Organizing Committee operatively. The decision of the Chairman of the Organizing Committee on such issues is final.

6.7 The results of the Olympiad will be posted on **December 11, 2020** on the official website of Karaganda University of the name of academician E.A. Buketov.

6.8 The content of materials sent to the Competition should not contradict the legislation of the RK. Materials that offend the dignity and feelings of others will not be accepted.

6.9 The responsibility for copyright observance for the works participating in the Olympiad is borne by the participant (team) and the scientific director who sent the work to the Olympiad.

6.10 The organizers have the right to use the sent materials for open placement on the University website and in social networks.

7.1 Applications for participation in the Olympiad shall be submitted electronically in the form specified in Appendix 1 of these Regulations to the e-mail: <u>ksu.bua@mail.ru</u> by November 30, 2020.
